Council Process for Community Led Projects - Update June 2025 - Proposed Seating on Gannet Point Headland

Background - Last year a project to put seating on Gannet Point Headland was proposed at community meetings to BPKTCA & S&R with both organisations supporting the proposal in principal. Councillor Gillian Boyd also supported the project. This project was to be funded by the community as well as maintained by the community as it was accepted that Shoalhaven Council had no funds to pay for it. The proposal was taken to a Council meeting and the decision was made that prior to projects of this type being approved, a policy from Council was required on how to consider and manage self funded community led projects now and into the future. Council management was asked to develop that policy.

Current Status - Since that time I have contacted Councillor Boyd and Council management a number of times asking for updates on the progress of this policy. Recently Catherine Waerner, Project Officer, Open Space and Recreation Planning, Shoalhaven City Council, telephoned me advising that the policy for self funded community led projects is nearly completed with final testing on a portal being done. Catherine advised that she would be in contact again when the portal for applications is complete at which time we will need to submit another proposal for the Gannet Point Seating Project through that portal.

Council will then consider all the elements of the submitted project including any staffing requirement within Council required to manage the project during its implementation and going forward once it is completed. I explained to Catherine that the community would be paying for and maintaining the project and we would work with Council to ensure that the project met Council guidelines on safety of the structures, environmental impact, etc.

Whilst it has taken some time from the original concept for seating at Gannett Point Headland presented to BPKTCA to have any progress, it appears that at least there is progress from Council on a policy to manage this and other community led projects. As limited to no funding can be expected from Council on projects in the near future, unless of course grants are successfully sourced, community led projects are a way forward for projects within our community to be proposed and completed.

I believe that the seating at Gannet Point Headland and possible other community led projects also fits into the strategic plan for our villages.

I advised Catherine that I would keep the BPKTCA and S&R informed of progress of the portal for community led projects and any other comments from Council as well as keeping them informed on this project.

It is understood that no project, whether self funded or not, is guaranteed. Council needs to ensure that the proposal is within their guidelines and there also needs to be environmental, etc, studies done. Sometimes these studies are and have been too costly for the community to fund without grants, etc. And sometimes projects have stopped because of these apparently necessary and costly, studies. Still I think it is important that we continue to develop projects that are wanted by the community, meet community needs and can be self funded.

I am away at the moment travelling Australia and hence cannot make the next General Meeting to update the community in person. I have emailed Councillor Gillian Boyd so she is aware of the current status, and may be able to answer questions if she is at the BPKTCA meeting. Alternatively, I am mostly contactable by phone or email if further information is required.

I look forward to any feedback from the BPKTCA and your continued support for this project. I will keep you up to date on any further information from Council on the portal for community led projects.
