Subcommittee reports

Community Connect:

Stage 1: Handrails at culverts now in place along the path

Stage 2: In progress. It started 5 May, 20 weeks to completion, weather dependent.

Final section Scerri Drive to Kioloa Beach: on crown land and part of land rights application. Just need to upgrade the current path with FRP to make it weatherproof, a concrete path is not necessarily required.

Action: Noted-Keep Kioloa bush care group up to date with developments.

Action: TS to reach out to local First Nations Elders re support for this work.

SCC community plan

There are many similarities between SCC CSP and BPKTCA CSP. A feedback letter was sent to SCC from BPKTCA noting alignment between the 2 plans and how they can work together.

Action: - copy of BPKTCA response to be forwarded to Gillian Boyd.

BPKTCA CSP

Consultation phase complete, drafting is substantially complete. Now working through graphics, which will hopefully be done locally. Working within a strict budget is very important that the final plan is presented properly. Thanks to Sport & Rec for funding CSP. Plan is to present the CSP to the community at the July general meeting, date of which can be changed if the Plan is not quite ready.

Once the CSP is formally recognized by BPKTCA it will be presented to SCC. Then working groups can be formed to address the projects.

LOCAL Character

State Govt proposal to recognise the character of villages in the LEP has again been rejected by SCC.

An alternative proposal is that Local Character be recognised in the DCP. DCP can be amended at any time to include character statement. It is important to include our community's idea of character in all future developments. LEP is a legal planning instrument and carries more weight than DCP and will therefore better protect the character of our 3 villages.

Motion: that BPKTCA write to SCC asking that the views of BPKTCA be considered at the Council meeting of 17.06.25 and support the incorporation of character objectives in the pending updated LEP, as per the Department of Planning recommendation.

BPKTCA also objects to the proposal to form a Planning and Development Committee of Councilors which is essentially a Council staff task. This work should be in the hands of those with academic and industry town planning experience and certainly not as currently proposed.

Moved: Peter Longstaff. Second: Linda Lane. Carried unanimously

BPKTCA understands that a substantial proportion of CCBs similarly supports the Planning Proposal: Local Character (PP073) in its original form. BPKTCA continues to vigorously support maintaining local character. Noted there is no evidence to support character statements are a barrier to development.

Community led projects:

SCC is close to concluding the process for community led projects. There will be a portal on SCC web site to take you through the process.

There are already 2 projects on the table:

Seating at Gannett Beach

Last year BPKTCA wrote a letter to SCC supporting this project. Project is with SCC but remains in limbo while SCC work through community led projects process.

Proposed that 9 sandstone seats be placed in various locations on the Gannet Beach headland i.e. near the Flo Van. Project will meet the community's needs and Council requirements.

First aid safety devices on beaches

The current location of the AEDs are too far from the beaches. Lurlene has reached out and consulted with Manyana community, who have successfully installed First Aid stations on some of their beaches. Stations include rescue tubes, defib and shark bite kit. Locations to be discussed and agreed at a community general meeting.

All community led Projects will need to follow the final SCC online process, ensure successful implementation.

Action:- Report to the community when new SCC process is finalised and available online.

SCC financial position

An update has been received, and distributed to BPKTCA members, from Berry Forum. Noted the current financial year is almost finished. The financial review panel has been concentrating on chasing and reducing bad debts.

There was some discussion on reducing staff costs and improving employee costs per capita (ECpC) ratios. There is concerning talk circulating around 200 job losses. Noted that a number staff have left due to unrest. There are also "on ground" concerns as staff numbers are reduced. It is not desirable to lose too many skills as staff leave or take voluntarily redundancies. Routine maintenance jobs are not being carried out and lack of staff / funds blamed.

An independent review of the proposed waste facility is due this week to decide if it will be feasible.

Merry Beach caravan park sewerage facility.

On 3 June, a few executive members and interested community members visited Merry Beach Caravan Park for a tour of the sewerage facility. Josh, an independent contractor who manages the plant, guided us and explained the monitoring and reporting process. The results are published monthly and are available on the Ingenia Merry Beach web site. Julian, Senior Project Manager, was also available to answer our questions. Plants appear to be well run. Ingenia have recently spent \$4.2 million on upgrades with an expected \$600k in irrigation and other miscellaneous upgrades to complete next financial year. Ingenia acknowledged that there have been failings, and they are working with EPA as they work through their upgrades.

They have a bore in place which provides some of their water. Bore water passes through a reverse osmosis process to desalinate the water. Resulting brine is used for the toilets. They also collect water off the roofs of the newer cabins.

Noted no further action required, continue ongoing watch and report, but likely once per year.

Tasman Operation & Maintenance of their onsite STP Plant.

Unlike Merry Beach, Tasman is licensed under SCC. Unfortunately, SCC guidelines and scrutiny are of a lower standard than EPA. Tasma's plant is too small to be licensed under EPA state legislation so will remain licensed under SCC.

- Reports are not provided, or possibly don't even exist
- SCC advise that there are no problems at Tasman
- Operational Management report that we could obtain historically now seems to be protected by Copyright.
- Currently No E coli benchmark for treated water discharged into the sand dunes.
- Plant is possibly OK but still needs to be maintained and run properly. Otherwise, how does anyone know if there is an incident.
- GIPA results are slow.

Very strong community voice re concerns over operation of the local caravan parks. However, BPKTCA cannot proceed until GIPA results are to hand and we have actual data to work with.

BPKTCA is looking for someone with sewer treatment plant experience, who may be able to read and interpret Sewerage Treatment Plant results once they are finally received.

No parking sign

Peter has notified Transport NSW that the no parking signs, which were in position in the parking area where the highway turns into Bawley Point, need to be replaced. When coming from Bawley Point and turning onto the highway, visibility is reduced when vehicles are parked incorrectly.

Character Subcommittee

John Nelson suggested that a subcommittee be formed to let SCC know what we want before the LEP is finalized. Discussion to include character objectives and zonings. Tony to be included in the subcommittee.

Action: - TS to meet with JN and consider timing and composition/Brief for this subcommittee,

Kioloa oval upgrade / cricket nets

Noted that CSP has identified a need for upgrade of the Kioloa oval and cricket nets. This project will need a working group to take it forward.

Action: - CS-Sports & Rec to confirm what information regarding community support for Cricket Net upgrade they require to consider advancing this Project, can Clair Stephenson assist in this matter

Following on from my email last night, please consider the draft revised Recommendation below and be prepared to support it if a Notice of Motion can be put to the meeting tomorrow night.

Some of us have been working on character consideration for more than three years. To have this thrown out because of a lack of clarity in the Recommendation and misunderstandings would be a tragedy.

The SLEP does not provide specific provisions for character in the Aims of Plan or the Objectives of the relevant zones, so PP73 proposes two additions:

- An Aim which says - *"to protect and enhance the unique character of Shoalhaven's towns, villages and neighbourhoods, and the characteristic scenic landscapes that contribute to its liveability and identity."*
- An Objective in each zone, eg for the R2 zone (most of Berry) - *"To provide for development that is compatible with the identified existing or future desired character and amenity of the surrounding area."*

The Planning Proposal 073 additions are necessary to ensure that character is considered in all DA assessments by reference to the character statements in the DCP. This is just about facilitating consideration, which does not happen now. It does not impose any restrictions.

C. Recommendation (see attachment)

That Council:

1. Proceed to adopt Planning Proposal PP073 as exhibited, and using Council's delegation, forward to the NSW Parliamentary Counsel's Office to draft the resulting Amendment to Shoalhaven Local Environmental Plan (LEP) 2014 and proceed to finalisation.

PP073 additions to the SLEP are:

- A proposed new Aim: *to protect and enhance the unique character of Shoalhaven's towns, villages and neighbourhoods, and the characteristic scenic landscapes that contribute to its liveability and identity.*
 - Proposed additional Zone Objectives, eg for zone R2: *To provide for development that is compatible with the identified existing or future desired character and amenity of the surrounding area.*
2. Monitor the effectiveness and operation of the SLEP Amendment and provide a report detailing relevant outcomes and any resulting proposed improvements **when Council considers the New Land Use Planning scheme over the next two years.**
 3. Removed
 4. **Character statements for some localities are already included in the relevant area specific chapters in the Shoalhaven Development Control Plan (SDCP). The Shoalhaven Character Assessments Report (Roberts Day 2020, excluding the 'sensitivity to change' ratings) will be used on an interim basis for the other localities, if community-supported character statements are not available.** As part of the Stage 2 work on a New Land Use Planning scheme, consider the preparation of new or revised character statements with the community.
 5. Advise key stakeholders, including Community Consultative Bodies and those who made a submission during the exhibition period, of this decision and when the Amendment is made effective.
